DENIS DESJARDINS – Denis is the co-founder and President of Desjardins Seed Farm Ltd. He and his brother got their start by joining the family business as partners in 1994. Today they grow processing potatoes for McCain Foods Canada and Cavendish Farms across 3500 acres of farmland. The operation has earned top 10 awards from Cavendish Farms in 2021 and 2019 and from McCain Foods in 2019, 2017 and 2015. During his time in the industry, he's lent his expertise to help negotiate the acquisition of Bon Accord Seed Farm from the province of New Brunswick to Potatoes New Brunswick (PNB), as well as helping implement through legislature a Potato virus Y (PVY) virus cap for potatoes in New Brunswick. Desjardins previously served on the PNB Safety Net Committee and the PNB Processing Negotiation Committee and currently

serves on the National Program Advisory Committee (NPAC). He's also previously served as the PNB chairman, as well as on the Advisory Council to the New Brunswick's Minister of Agriculture, Aquaculture and Fisheries as a member. He has served on the CanAgPlus Board since 2021.

ALVIN KEENAN – Alvin Keenan, along with his brother Ray, owns and operates Rollo Bay Holdings where they grow, package, and market fresh potatoes to retailers and food service companies nationally and internationally. They are one of the largest agriculture entities in Eastern PEI and employ 40 people year-round. Rollo Bay Holdings was one of the leaders in fresh pack operations in advocating for food safety certification. Alvin has served his community and the agriculture industry in many capacities; currently he is Chairman of the PEI Grain Elevators Corporation, and Past President of the Canadian Horticultural Council. He has served as President of the PEI Federation of Agriculture, the PEI Farm Practices Review Board, Director of the Canadian Federation of Agriculture, and Director of the Canadian Agriculture Human Resource Council. Alvin has served on the CanAgPlus Board since 2018.



JODY MOTT – Since 2014, Jody Mott has served as Executive Director of the Holland Marsh Growers' Association, representing root crop producers and packers federally, provincially, and municipally. She is Chair of the Industry Standards and Food Safety Committee for the Fruit and Vegetables Growers of Canada and Vice-chair of the Vegetable Working Group since 2016. Jody has been a director on the CanAgPlus Board since 2016. She has served on several not-for-profit boards, including the Bradford Board of Trade, the Greater Golden Horseshoe Alliance, and the Bradford Minor Hockey Association. She has assisted many farmers implementing a food safety program. Jody has been involved in a wide range of projects to promote the interests of farmers and is passionate in her commitment to advancing agriculture.





ELIZABETH PATTILLO – Beth is currently the Food Safety & OHS Manager for Noggins Corner Farm II Ltd., and also involved with Kings Produce Ltd. Beth was involved in the food safety file with both the Fruit and Vegetable Growers of Canada (FVGC previously CHC) and the Canadian Produce Marketing Association (CPMA) for many years: notably, during both the development of the on-farm food safety program and manual and during the establishment of CanAgPlus. In 2008, she served as CPMA's Chair of the Board, and she continues to be an active member of the Past Chairs Advisory Council. As an agricultural microbiologist, onfarm food safety has long been Beth's passion. She is also a proud "Grammie Beth" to 15 incredible grandchildren and volunteers with the several trails and gardening organizations in Nova Scotia.
