



## CanadaGAP Options E and F

CanadaGAP now offers two additional certification options: Option E and Option F. These certification options are not GFSI-recognized, but were developed to respond to customer demands and to satisfy different market requirements. Program participants also requested more certification options following the introduction of stricter requirements in GFSI-recognized Options C and D, such as a passing score of 100% and no-notice unannounced audits.

### What are the similarities and differences?

May require 2 audits per year depending on timing of activities	<b>Option E:</b> Auditor can see harvesting one year, packing the next - the CB determines which activity is audited each year based on risk. 1 audit per year.

### ***Is there a cost difference between equivalent options?***

When it comes to the CanadaGAP annual program fee, there is no cost difference between equivalent options. Option C and Option E have the same annual program fee, and Option D and Option F have the same annual program fee. Audit costs for Option C and Option D, payable to the Certification Body, may be higher due to the increased cost of CAR closures, the additional administrative fees around managing no-notice unannounced audits, or other reasons.

### ***What benefit is there to switching options to E or F?***

Provided that the certification will be accepted by buyers, operations may see some benefits in possible reduced audit costs (e.g., related to fewer required CAR closures), less stress and hassle around unannounced audits (e.g., 2-5 days' notice compared to no-notice), and for some operations who are certified for production and packing of certain crops, no need for a second audit each season.

### ***How can an operation find out if a buyer will accept Option E or Option F?***

As always, program participants are advised to check with their buyers before making any changes to their certification option. **This is a critical step.** Buyers set their own requirements as to which CanadaGAP certification options are acceptable for their suppliers.

### ***How is an operation's certification option communicated?***

Each certificate clearly states the certification option, and whether or not it is GFSI-recognized. Additionally, buyers can quickly verify an operation's status and certification option by checking the list of certified companies on the CanadaGAP website or the certification body's public registry.

### ***How do operations switch to Option E or F?***

If a buyer has confirmed that certification option E or F is acceptable, program participants can simply download the change of status form from the CanadaGAP website ([www.canadagap.ca](http://www.canadagap.ca)), fill out the relevant section, have the form signed by the person responsible for the operation, and return it to the office. CanadaGAP will verify and process the information and share it with the Certification Body.

### ***Where can more information be found?***

The CanadaGAP website is updated continuously; this includes the Frequently Asked Questions (FAQs) which are updated to reflect current versions of the CanadaGAP program.
