<p>The five-day programme is designed to train potential auditors specifically for the CanadaGAP program. The course includes an intensive review of the CanadaGAP requirements, with the incorporation of practical examples specific to commodity or region, and optional HACCP and repacking and wholesaling components.</p> <ul style="list-style-type: none">• Days 1-4: Classroom training• Day 5: Pre-exam review and exams (CanadaGAP Auditor Exam, HACCP Exam, and Repacking and Wholesaling Exam)
